On a Travelwalk trip to the Land of Lincoln, the bus detoured to Nashville, Tennessee, where Sue Grey completed her 50th state walk. The big event occurred on Oct. 1, 2009, a day filled with sunshine, smiles and special memories. Old walking friends Teresa Kennedy and RoseMarie McLean were waiting with a welcome sign at the Start Point (See picture). This surprise appearance completed the circle for Sue as her first walks were done in the company of Van Corlear Elementary School colleagues Teresa, Rose, Chris Morroni, Jen Paley and Liz Walsh.

Sue first started volkswalking with the Van teachers after school on the Wednesday evening walks and was immediately hooked on the idea of walking for "fun and fitness." This led quickly to joining the group as they traveled on their fifty state quest. Sue reports she never thought she would accomplish the goal herself, but one trip led to another until the goal became a reality in less than nine years.

What were some highlights for Sue? She said she has special memories of the Cooper Mountain walk in Colorado because she shared the experience with her son Mike. The Cliff Walk in Rhode Island was memorable for the company of a special cousin, Patti, who has joined with Sue on adventures since childhood. Of course those Van friends included Sue on their journeys to the Northwest where a cricket plague in Montana covered the windshield and the roads adding the sound of crunching bugs to the laughter coming from within the car. One time, the group walked Montpelier at midnight with one flashlight to five people. Needless to say, this was before the group retired when no one thought anything of working all day, driving three or more hours, and starting a walk upon arrival at a destination.

Sue is very grateful for Travelwalk because she always learns so much on Marion's trips. She said she has become enriched by the history on the Lincoln trip, the natural beauty of the National Parks in the Southwest, native culture in Alaska, or the just plain fun of walking with thousands across the Mackinaw Bridge. The Washington, DC, walk does stand out as another highlight because, Sue reported, it was so moving to walk past the monuments honoring those who have made our nation the great place it is. Finally, one thing that Sue mentioned she will never forget is having her name announced from the stage of The Grand Ole Opry the night she finished her last walk.
