THE REVOLUTION IS OVER – Barbara Kolapakka

The Revolution is over, the American Revolution Walks special event program, that is. The program officially ended December 31, 2008 although participants may redeem their books for an award through March 31, 2009. To date 267 books have been sent in for a 59% redemption rate.

From the program's inception April 1, 2004, until last March 31 when we stopped book sales, we sold 455 books for a total income of \$3,640. Over the program's life, we spent a total of \$1,328.67 for the following expenses:

Printing \$ 21.70 Postage 265.83 Awards 874.44 Supplies 166.70

The net income of the program, \$2,311.33, was split 50/50 with AVA in accordance with special event program requirements. Thus our club netted \$1,155.67 from the program's operation.

My thanks to all of the club members who purchased books and helped the program get started.

ESCV FRIEND, ROBERT C. TAYLOR - Paula and Chase Pugliese

It was with profound sadness that we learned of the death of Robert C. Taylor, Schodack Island State Park manager.

When we first approached Rob in 2002 to consider a volkswalk, Schodack Island State Park was in the process of being opened to the public. Rob was extremely enthusiastic and helpful in planning and coordinating the March for Parks 2003 walk. We personally witnessed Rob's dedication and diligence in preparing the site for the March 2003 walk. The trails were groomed, colored trail markings posted on trees and water was turned on for the facilities. Newly created maps were produced for our usage. Rob and one part-time staff person personally completed every detail for our walk. Rob was so proud of Schodack Island State Park and he personally wanted everyone to share its Native American history and environmental beauty.

Over one hundred walkers participated in our first walk at the park. We remember that Rob just glowed with pride at the event. A certificate of ESCV thanks to Rob and his staff was framed and hung in the park manager's office at Schodack Island.

We understand that Rob wrote grants to obtain added funds for park improvements using our ESCV walk as a basis for his requests. We believe that the 2003 walk marked the highest daily attendance at Schodack Island State Park. ESCV returned in March 2004 and July 2006 as Saturday events and in May 2008 as a Wednesday walk. Each of those walks confirmed Rob's commitment and dedication, as significant improvements to the park were evident to all.

Mr. Taylor, 47, died November 27, 2008.
