## WEDNESDAY, JUNE 16th WALK LOCATION CHANGED!! - Winnie Balz

The gates are locked at Thacher Park so we have a new location for the June 16th Wednesday walk. The walk will start at the Emma Treadwell Thacher Nature Center. The Nature Center is located near Thacher Park and is part of the Thompson's Lake State Park complex.

Directions from Albany: Take exit 4 (rte 85) off I - 90, continue on 85 West for approx. 12 mi. to route 157, bear right onto 157 and continue through Thacher Park. After leaving the park, turn right on Ketcham Road (route 256), drive 1 mile to Nature Center Way on left. The parking lot is located 0.4 mile down Nature Center Way.

Directions from the Village of Altamont: Cross the railroad tracks, bear right on 156W. up the hill-stay on route 156 until you see a sign for Thacher Park - left on route 157 (Thompson Lake Rd.) drive on rte. 257 passing by route 157A (don't take it!) - watch for signs to Thacher Park again and take a left on route 256 (Ketcham Road) - then a right onto Nature Center Way - 0.4 mile to parking lot.

5K route - Will follow trails within the Thompson Lake State Park property.

10K route - Will be on trails that will also include connecting trails to the Long Path in and outside of the park boundary. The connecting trail is new, care must be taken for roots and mud.

The Nature Center Building will be available for the morning walk; there are bathrooms inside but the building closes at 5PM - So the evening walkers are encouraged to stop for a bathroom break perhaps in Altamont at the Stewart's place..

# ESCV TO HOLD DAVE SKINNER MEMORIAL WALK IN GLOVERSVILLE, NY SATURDAY, JUNE 26 – Eileen Skinner

On June 26, in Gloversville, NY a walk to honor Dave Skinner (1947-2007). Gloversville (once called "Glove Capital of the World") is about 40 miles west and north of Albany, NY in Fulton County. David was born and is buried in Gloversville.

David served as President of Empire State Capital Volkssporters from 2004-2006 and also served as Vice President for many years. He was always willing to help out with any aspect of club activities and he held memberships in many nearby volkssport clubs.

I've laid out this trail to explore many areas of the city, from the historic downtown, a rail trail, old churches, a museum, unique veteran memorials, a Carnegie Library and old neighborhoods with a stop in Prospect Cemetery to pay respects to David before returning to Holy Spirit Catholic Church, 149 S. Main St., our Start/Finish for this Walk.

Starting times are 9-10:30 a.m. We hope to have a restaurant to gather after the walk for lunch on your own.
